FOSTER AGREEMENT

I, _____ (hereinafter referred to as FOSTER FAMILY), do this _____ day of _____, 20____, enter into this Foster Agreement and acknowledge receipt from NEW HOPE CATTLE DOGS RESCUE AND REHOMING, INC. (hereinafter referred to as NEW HOPE CATTLE DOGS) the following foster dog named, _____ (hereinafter referred to as FOSTER DOG) into my home. I understand that this contract will be provided for, with the best of my ability, in following the terms and conditions below.

I understand that this Foster Contract can be amended as needed for the best consideration of the FOSTER DOG(s), and that the FOSTER FAMILY should personally return the living FOSTER DOG(s) to NEW HOPE CATTLE DOGS to release NEW HOPE CATTLE DOGS of any further liability of this FOSTER DOG(s), with this Foster Family.

TERMS AND CONDITIONS

In addition, FOSTER FAMILY agrees to the following terms and provisions:

1. _____ (initial) FOSTER FAMILY agrees to take the FOSTER DOG to a NEW HOPE CATTLE DOGS approved veterinarian, as scheduled by NEW HOPE CATTLE DOGS, as such appointments are made. NEW HOPE CATTLE DOGS keeps all FOSTER DOG(s) under veterinary care until they are adopted.
2. _____ (initial) FOSTER FAMILY agrees to abide by the following terms in caring for the FOSTER DOG:
 - a. _____ (initial) The FOSTER FAMILY will provide a safe and loving home environment.
 - b. _____ (initial) The FOSTER FAMILY will treat the FOSTER DOG as if they were one of their own pets.
 - c. _____ (initial) The FOSTER FAMILY will provide humane treatment in accordance with all current and future state, county and local laws and ordinances where FOSTER FAMILY resides.
 - d. _____ (initial) The FOSTER DOG will not ride loose or be tethered/tied or chained in the back of an open-bed truck
 - e. _____ (initial) The FOSTER DOG will not be allowed to roam free in populated or urban areas or in violation of any laws.
 - f. _____ (initial) The FOSTER DOG will be leashed and handled by a responsible person or kept in a safe and secure enclosure and not allowed off leash at anytime outside a contained yard.
 - g. _____ (initial) The FOSTER DOG will not be tethered or tied/chained as a means of confinement.
 - h. _____ (initial) The FOSTER FAMILY warrants that the FOSTER DOG will not be contained solely by a hidden fence.
 - i. _____ (initial) The FOSTER DOG(s) will not be solely an outside pet and FOSTER FAMILY agrees that when the FOSTER DOG is outside it shall be protected from the elements and provided with adequate food, water and confinement.
 - j. _____ (initial) The FOSTER FAMILY agrees to take the FOSTER DOG(s) to a NEW HOPE CATTLE DOGS approved licensed veterinarian to provide the FOSTER DOG with necessary veterinary care upon emergency sickness, disease and/or injury. A list of NEW HOPE CATTLE DOGS approved licensed veterinarians and emergency clinics will be given to the foster family. At no time is a FOSTER DOG to be taken to the FOSTER FAMILY'S personal vet with expected reimbursement without written approval of the President and Board of Directors of NEW HOPE CATTLE DOGS.
 - k. _____ (initial) The FOSTER FAMILY understands that there are costs involved in maintaining a FOSTER DOG(s) and agrees to assume full responsibility for a quality food as provided or

recommended by NEW HOPE CATTLE DOGS, clean and fresh water, flea and tick care as needed, grooming and basic health problems including administering any and all medications, vitamins or supplements as provided or recommended by NEW HOPE CATTLE DOGS.

- l. [REDACTED] (initial) At the time the FOSTER FAMILY takes possession of the FOSTER DOG(s), NEW HOPE CATTLE DOGS has already provided – at a minimum – the following vaccinations and tests at the intervals required by law and/or advised by their veterinarian: rabies vaccine, fecal test, heartworm test and distemper/parvo combination vaccine (DHPP), unless it is agreed upon by both parties and initialed here [REDACTED] that the FOSTER DOG(s) will be taken into the veterinarian for a full health check-up where they will receive these vaccinations and tests as scheduled by an NEW HOPE CATTLE DOGS representative with a NEW HOPE CATTLE DOGS approved veterinarian within two weeks of possession.
- m. [REDACTED] (initial) If for any reason this FOSTER DOG(s) has not completed its medical treatments (i.e. heartworm treatment, worm treatment, spay, neuter, etc.) prior to the execution of this contract, FOSTER FAMILY agrees to work with NEW HOPE CATTLE DOGS to attend all appointments and follow-up visits that need to be made in order to have the FOSTER DOG(s) healthy and ready for adoption. FOSTER FAMILY acknowledges that until this has been accomplished, NEW HOPE CATTLE DOGS has the right to and will reclaim the FOSTER DOG if the appointments are not made.
- n. [REDACTED] (initial) FOSTER FAMILY also agrees that they will discuss with their personal veterinarian about the fostering of a dog and to seek advice whether he/she recommends a six-month distemper/parvo booster, bordatella booster, tick and/or flea treatments and/or regular deworming schedule for the family's personal pets to prevent any disease transmission between personal pets and FOSTER DOG. If the FOSTER FAMILY decides NOT to take the extra precaution with additional boosters, tick and/or flea treatments and deworming schedules, NEW HOPE CATTLE DOGS will not be responsible for the family's personal pets if an outbreak should occur.
- o. [REDACTED] (initial) FOSTER FAMILY agrees that the FOSTER DOG(s) will reside in his/her home, will be kept as a household pet and will not be used as a hunting or guard dog(s).
- p. [REDACTED] (initial) FOSTER FAMILY agrees to provide a collar, if one is not provided by NEW HOPE CATTLE DOGS, and identification tag for the FOSTER DOG(s) to wear at all times when allowed outdoors and to ensure that a NEW HOPE CATTLE DOGS identification tag will also remain affixed to the collar.
- q. [REDACTED] (initial) NEW HOPE CATTLE DOGS makes no warranties or representations regarding the FOSTER DOG(s)'s health or temperament. It is agreed and understood by the FOSTER FAMILY that while every effort is made to provide an accurate history and assessment of a dog, NEW HOPE CATTLE DOGS does not warranty any FOSTER DOG(s) regarding medical status, behavior or disposition. It is further agreed that environmental changes may effect and change the temperament of the FOSTER DOG(s) and that NEW HOPE CATTLE DOGS has no liability or responsibility of any nature regarding defects with the FOSTER DOG(s), or injuries or damage to any person or property which may be caused by the FOSTER DOG (s). FOSTER FAMILY agrees to indemnify and hold harmless NEW HOPE CATTLE DOGS, its members and representatives against any and all claims, known or unknown, now or hereafter arising in connection with this FOSTER DOG(s).
- r. [REDACTED] (initial) FOSTER FAMILY agrees that NEW HOPE CATTLE DOGS is the sole and rightful owner to the FOSTER DOG(s) and consents to the examination of this FOSTER DOG(s) by NEW HOPE CATTLE DOGS at any time and acknowledges that NEW HOPE CATTLE DOGS has the right to reclaim the FOSTER DOG(s) at any time and for any reason without notification.
- s. [REDACTED] (initial) FOSTER FAMILY agrees that if for any reason, he/she cannot keep this FOSTER DOG(s); he/she shall return FOSTER DOG(s) to NEW HOPE CATTLE DOGS. The FOSTER DOG(s) shall not be given away, sold, exchanged or adopted out without prior written consent of NEW HOPE CATTLE DOGS and all completed paperwork for a legal adoption. FOSTER FAMILY understands that any friend or family member who wishes to take ownership of this FOSTER

DOG(s) will be required to apply to NEW HOPE CATTLE DOGS for the right to adopt and/or foster the FOSTER DOG.

- t. [redacted] (initial) It is agreed and understood by FOSTER FAMILY and NEW HOPE CATTLE DOGS that this written agreement sets forth all promises, agreements, conditions, and understanding between them, oral or written, and that both parties have fully read and understood all of this agreement.
- u. [redacted] (initial) FOSTER FAMILY agrees to pay NEW HOPE CATTLE DOGS for any and all expenses, including court costs and reasonable attorney's fees, in enforcing the terms and provisions of this contract. Payment of these damages shall not excuse FOSTER FAMILY from returning the FOSTER DOG(s) to NEW HOPE CATTLE DOGS.
- v. [redacted] (initial) FOSTER FAMILY will have first opportunity to adopt their FOSTER DOG, but agrees that this will done following the adoption procedures set forth by NEW HOPE CATTLE DOGS and that the adoption is contingent upon approval of the adoption committee.

3. NEW HOPE CATTLE DOGS and FOSTER FAMILY can agree to extend this agreement to cover all future FOSTER DOG (S) by initialing here: [redacted] FOSTER FAMILY [redacted] NEW HOPE CATTLE DOGS. A list of FOSTER DOG'S names will be attached to this agreement.

BY SIGNING THIS CONTRACT, I AGREE TO ALLOW AGENTS OF NEW HOPE CATTLE DOGS TO ENTER MY PROPERTY FOR THE PURPOSE OF REMOVING THIS FOSTER DOG FROM MY CUSTODY IF I DO NOT COMPLY WITH THE ABOVE TERMS.

I have read and received a copy of, and hereby agree to abide by, ALL THE TERMS AND CONDITIONS of this Agreement.
