Releaser warrants that he has fully and completely disclosed to the NHCD all information known to Releaser concerning the temperament and behavior characteristics of the animal being released. Releaser warrants that to the best of his knowledge, this animal has never bitten any person, nor shown aggressive behavior toward any person, nor had any serious medical problems unless specified and detailed on attached note and signed off by NHCD agent and releaser.
